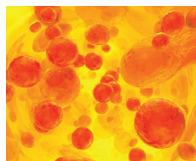

**ON THE COVER** Red blood cells, 3D rendering. During the normal 120-day life span of a red blood cell, a nonenzymatic reaction occurs between glucose and hemoglobin, forming glycated hemoglobin. Millions of measurements of hemoglobin A<sub>1c</sub> (Hb A<sub>1c</sub>), the major fraction of glycated hemoglobin, are performed each year in hospital laboratories and point-of-care facilities.
